

Current Scenario of Carpet Market of Bangladesh and Its Future Perspective

Abstract

Textile industries in Bangladesh have grown rapidly and have an over powering existence in the economic life of the country, where the carpet is playing a very momentous role. In the last few years, the export of carpets has increased significantly. The main focus of this project is to analyze the recent market position of carpets manufacturing and export from Bangladesh globally and highlight the ups & downs, its threat & its probability in the export sector in the world. A comprehensive literature survey has been made in this respect and deliberated in the paper.

1. Introduction

Any decorative textile-like Carpet and Rugs are generally manufactured with thick material and at present, itis commonly intended as a floor covering. People used the term 'carpet' as cover, such as table cover or wall hanging till the 19th century. [1] Generally carpets are constructed from woven, knitted, knotted, braided, tufted or nonwoven materials. Carpet materials can be used for floor coverings, table covering and coverings as well. The word carpet and rugs can be used interchangeably. [2] Pile and tapestry weaving have a strong relation in obtaining carpet and rugs manufacturing. [3] Commodities carpet have properties which can be their defined by physical features moreover, by its socially given denotation. Carpets have limited life as they have functional values- though if good material is used in manufacturing carpet it will not last forever. [4] Bangladesh has a primitive ironic tradition in the textile and manufacturing and textile is a significant portion of our economy. Also, the textile industry plays a very cabalistic role by contributing to the industrial output, employment generation, and export earnings of the country. Even a carpet is

playing a serious role in the textile market of Bangladesh. The end-use performance will be affected by fiber selection and yarn construction. Manufacturers are a valued resource in determining the fiber most appropriate to the application and the budget. [5] Carpets that are produced in specific sizes are available for household use in massively trafficked areas that necessitate commercial grades. The classic rolls of carpet are generated in a large number of standard and fashion colors. Houses and offices in Australia, New Zealand, and the United States were embellished with Bangladeshi carpets between the 1970s and 1990s. But, the degeneration has occurred industry's because of the lack of technological advancement and novelty. The local demand is exceedingly met by products imported from Saudi Arabia, China, The United Arab Emirates, Spain, Iran, Canada, France, India, and Belgium. The carpet business had gradually uplifted after the shutdown to reach 70% of the prepandemic level. However. entrepreneurs who manufacture carpets and rugs from jute facing difficulties to sustain their businesses because service ability of Jute rugs are limited and expensive than others. Synthetic materials are used to make carpets and they now have overtaken the market. [6]



2. Material & Method

Primary and secondary data collection has been done through some sources. Primary data has been collected through factories and fieldwork. Thereby we're able to get knowledge about carpet. And secondary data has been collected through Government publications, books, journal articles and websites. The export data of recent years has been collected from the publications of the export promotion bureau of Bangladesh.

3. Result & Discussion 3.1 Top Carpet Manufacturers in Bangladesh

In Bangladesh, a large number of manufacturers are involved manufacturing carpets and rugs. Among them, there is quite a few that lead the carpet market. Top carpet manufacturers in Bangladesh are Sagar Spinning Mills Limited, Riyad Carpet Emporium, Al-Amin Carpet Corner & Bedding House, Ismail Carpet Industries Limited, and Mohsen Jute Mills Limited. Also Carpet Bazar, Saleh Carpet Mills Limited, Mishu Carpet Limited, Carpets & Interiors, and People's Jute Mills Limited are contributing to the economy of this country.

3.2 Fiber's Used in the Carpet in Bangladesh

Natural fibers mainly used for carpet manufacturing are wool, silk, jute, coir, flax, sisal and seagrass. Moreover some manmade fibers are also used, such as acrylic, polyamide, polyester, polypropylene, and viscose.

3.3 Varieties of Carpets Used in Bangladesh

3.4 Contribution of Jute to Floor Coverings:

From Jute different types of fabrics are made such as canvas, hessian cloth, carpet backing cloth (CBC), scrim, sacking etc. For this reason Jute can be considered as a home textile material. CBC can be divided into two categories- 1st primary CBC and 2nd Secondary CBC. Primary CBC offers a tufting surface, where secondary CBC is used as overlay from primary backing by attaching onto it. Jute floor coverings can be of woven, piled, and tufted carpets.



SATRANJI is very popular in Bangladesh as floor cover and home decor. it is a traditional handicraft of Bangladesh.[8]




Figure 1. Country wise carpet& other floor coverings export data on chart 2020-2021.

The graph (figure no-01) illustrates about recent (FY July-December 2020-21) country-wise export performance of carpet & other floor coverings. Here is a comparison of the top countries that are involved in carpet exporting. We can see on the graph that Great Britain is in the top position for US\$ 182089 million, the most export value. France is the second top amounting to US\$52332.07 country million. Other countries like Netherlands, Germany, and India seemed to average carpet exporters in the global export market. The graph shows US is the lowest exporter in the export market amounting to US\$ 3483.06 million. [9]




Figure 2. Yearly export performance of carpet on graph (fy 2015-21).

Export earnings of Bangladesh from the carpet during FY 2015-16 to 2020-21were inconstant. During FY 2020-21 amounted to US\$ 33.54 million as against US\$ 21.13 million during FY 2019-20 showing an increase of US\$ 12.41 million. From FY



2017-2018 to FY 2018-2019 export earnings covered US\$ 17 million to US\$ 19.49 million which increased respectively. However, FY 2017-18 as against 2016-17 showed a decrease of US\$ 0.5 million, and FY 2016-17 as against 2015-16 also showed a decrease of US\$ 0.44 million.[9]




Figure 3. Monthly export performances (carpet) on graph (fy 2020-21).




Figure 4. Monthly export performances (carpet) on graph (fy 2020-21).

In the graph (Figures 3 & 4), we can see that the export of carpets for 2019-20 is still at US\$ 21.13 million. For the years 2020-21, we had been shooting the target

of exporting US\$ 30 million. For July 2020 our strategic target was US\$ 2.52 million which is gradually increased to US\$ 28.33 million by July-June 2020-21.

In July 2020, our export performance 2020-21 was US\$ 3.43 million which was increased to US\$ 33.54 million by July-June 2020-21. From July 2019, where export performance was US\$ 2.14 million it also increased impressively up to US\$ 21.13 million by July-June 2020-21. Now we can also notice that in July 2020 the % change of export performance over the export target gradually drop out from US\$ 36.11 million to US\$ 20.51 million by July-October 2020-21, then increased from US\$ 20.51million to US\$ 27.64 million between July-October to July December 2020-21. Then it started again decrease from US\$ 27.64million to US\$ 11.8 million between July-December to July-June 2020-21 [9].



3.8 Market share of Carpets and Rugs importers:




Figure 5. Global carpet & rugs market.

In the figure, it is quite clear that North America has been dominantly moving forward in the world wide carpets and rugs market and is estimated to be persistent in the imminent years whither Asia Pacific, Europe, and South America are standing too backward.
